# General Terms and Conditions of Travel The Section for Travel Consultation Contract

## Article 1. Scope

Travel Consultation Contract entered into between Cab Station Co., Ltd. ("the Company") and a traveller is subject to this stipulation. For indefinite matters in this stipulation are restricted by conventions established by laws and regulations in general.

(2) As long as the Company does not violate the laws and regulations and makes a special contract in writing within the extent of the traveller's non-disadvantages, regardless of the provision of the preceding paragraph, the special contract takes precedence.

### **Article 2. Definition of Travel Consultation Contract**

"Travel Consultation Contract" in this stipulation refers to the contract the Company undertakes upon the receipt of the travel handling fee for the consultation ("consultation fee") by the delegation of the traveller, to provide the following services:

- i. Providing a necessary advice for the traveller to create a travel plan.
- ii. Creating a travel plan.
- iii. Creating an estimate of expenses required for a travel.
- iv. Providing information on travel destinations and facilities of transportation and accommodation.
- v. Providing any other information or advices necessary on travelling.

#### Article 3. Establishment of the Contract

The traveller who intends to conclude Travel Consultation Contract with the Company must fill in the application form in order and submit it to the Company.

- (2) Travel Consultation Contract shall be established when the Company accepts the conclusion of the contract and the application form set forth in the preceding paragraph.
- (3) Regardless of the provisions of the preceding two paragraphs, the Company may accept the application of Travel Consultation Contract via telephone, mail, facsimile or other means of communications without receiving the submission of the application form. In this case, Travel Consultation Contract shall be established when the Company accepts the conclusion of the contract.
- (4) The Company may refuse to conclude Travel Consultation Contract in the following cases:
- i. The contents of the traveller's consultation are contrary to public orders and morals or have a risk of violating the laws and regulations conducted in the destination of travel.
- ii. The traveller is found to be associated with gangsters, gang quasi-members, gang parties, gang related companies, the General Assembly or any other anti-social groups.
- iii. The traveller makes violent actions or unreasonable demands against the Company, threatens the Company with force or violence, or commits any violent acts equivalent to these in relation to the transactions.
- iv. The traveller spreads the rumour, using the power of fraudulent to damage the reputation or obstruct the business of the Company, or takes any other acts equivalent to these.
- v. Other particular circumstances of the Company business.

# Article 4. Consultation Fee

When the Company provides the services stated in the provisions of Article 2, the traveller must pay the prescribed consultation fee to the Company by the date specified by the Company.

## Article 5. Cancellation of the Contract

When the traveller is found to be applicable to any of the item (ii) to (iv) in the fourth paragraph of Article 3, the Company may cancel Travel Consultation Contract.

## Article 6. Liability of the Company

When, in carrying out Travel Consultation Contract, the Company caused any damage to the traveller by intention or negligence, the Company fulfils the appointed liabilities and compensates for the damage. Provided, that the claim is made to the Company within 6 months from the day after the occurrence of the damage.

(2) The Company does not guarantee that the Company can actually arrange the transportation and accommodation facilities and the like stated in the travel plan the Company has created. The Company, therefore, has no liabilities even if the contract could not be concluded with the transportation and accommodation facilities and the like to provide transportation, accommodation or other travel related services these facilities provide, due to the reason of fullness or the like.
